SUBJECT: Minutes

You will find the Minutes of the 491st Stated Meeting of the Presbytery of Des Moines held on January 19, 2013 at the Covenant Presbyterian Church of West Des Moines following this letter. Most members are receiving the minutes by going online to download them from our Presbytery web site. Only those without Internet access receive printed copies.

We worshiped and received the Sacrament of the Lord's Supper. We spent a more informal time in conversing with committees and persons at tables rather than on the floor of the meeting. We had an exciting time as we installed Teaching Elder Katherine Pater as our new Mission Co-Worker in El Salvador. We dealt with Proposed Amendments to the Constitution of our denomination. We commissioned Teaching Elder Jim Woodworth to the National Response Team of the Presbyterian Disaster Assistance organization. Hearing that a unique set of circumstances left us with a surplus, we approved our 2013 Budget and did not increase the Per Capita Assessment. We formally dissolved the United Presbyterian Church of Pitzer. We commissioned Sara Hopkins as a Commissioner Ruling Elder at 1st Church in Newton. You may remember some other things as well.

WELCOME BY HOST CHURCH

Teaching Elder Jan Scott, pastor of the Covenant Church, welcomed the Presbytery.

WORSHIP

The Presbytery entered into a time of worship. Leaders for worship were Teaching Elders David Kincaide (Dexter, First and Greenfield, First), Tim Maxa (Lenox United, Sharpsburg), Sara Palmer (HR), and Ruling Elder Carol Ferrell (Clive, Heartland). Ruling Elder Cindy Ray (Leon, First) and Teaching Elder Don Elly (HR) offered the sermon based on John 9 focusing on seeing the light and being the light. Cindy focused on what might happen to the blind man when Jesus gives him sight, and what it cost him as he told about Jesus. Don focused on in sights gained from the passage and from Cindy, calling our attention to how we resist change, even when it comes from God. Music Leaders were Teaching Elder Mary Beth Mardis-LeCroy (At Large), and Julianne Lawrence as well as the Crescendo Bell Choir from the Covenant Church. Teaching Elder Jan Scott, pastor of the Covenant Church, administered the Sacrament of the Lord's Supper. The offering for the day goes to disaster relief.

REPORT OF THE STATED CLERK

Stated Clerk Phil Barrett presented the following items of information to the Presbytery:

- I-I-1 All reports have been filed with the Synod of Lakes and Prairies and the General Assembly as of this date, and all correspondence received on behalf of the Presbytery has been assigned, referred or answered.
- I-I-2 The current Form of Government (G-3.0301) is significantly less prescriptive than previous editions regarding determination of the balance of ruling elders and teaching elders as members of a presbytery. It simply states that the number of elders should be "as equal as possible." As part of this, ruling elders who are officers of the presbytery are members and that presbyteries may provide for enrollment of ruling elders who are moderators of committees and commissions as members. It does not address Commissioned Ruling Elders who are serving in pastoral positions. (A change to this will be addressed in the Bills and Overtures Task Group report today.) Following this section brings us to 76 Teaching Elders and 65 Ruling Elders, requiring us to ask 11 congregations to send an extra ruling elder commissioner. If we follow the section in the 2009-2011 Edition of the Book of Order, which we have followed until we have developed a new structure and manuals, we could also have ruling elders who are members by virtue of serving as moderators or members of a committee on ministry as well. This would make the count 76 Teaching Elders and 78 Ruling Elders. Attempting to follow the two editions, I think we are in compliance with them, and we especially fit the current edition's "as equal as possible" language.

- I-I-5 We are still open for presbytery meeting hosts in May (21) and November (12).
- I-I-6 This is to provide notice to you that I will be bringing the following recommendation for a change in the Presbytery By-Laws to the May 21, 2013 Stated Meeting of the Presbytery:
 - That the Presbytery change its January meeting date from the third Saturday in January to the second Saturday in February beginning in 2014.

There are two reasons for this. First is the difficulty we have in getting year end reports and General Mission Pledges received in the office in enough time to close the prior year's books and prepare the Expense Budget and financial reports in time to get them in the call to the meeting. Second is the relatively short time sessions and congregations have to study Proposed Amendments to the Constitution of our denomination. The booklets with these proposals are distributed in early November and voted on in mid-January. In between are Thanksgiving, Advent, Christmas and New Year's, limiting available time for thoughtful and thorough conversations. We must vote on these in January because the May date generally occurs after the date voting results are due from presbyteries.

I am providing this information to meet the requirements of our presbytery's By-Laws which require a 30 day notice for proposed By-Law changes.

- A-A-5 In response to the Committee's action to approve the terms of call for new Mission Co-Worker Rev. Katherine Pater, the following recommendations were presented from the floor:
 - 1. That the Presbytery temporarily set aside its guidelines for clergy and salary minimums in order to process the call to the Mission Co-Worker to El Salvador.

Rationale: The terms of call as presented do not meet the standards of our guidelines for clergy in this presbytery.

- 2. That we add the following items to the terms of call:
 - a) Four weeks' vacation

- b) One week study leave
- c) Continuing Education Allowance of \$600.00
- 3. That the Moderator of the Leadership Council appoint a five person task force with the following representatives:
 - Leadership Council Will serve as Moderator of the Task Force
 - Compañeros
 - Congregational Care and Development Committee
 - Social Ministries Task Force
 - Budget and Finance Committee

Purpose of Task Force:

- 1. Consult with our national PC(USA) World Mission office personnel, namely Ben Albers, to learn of their guidelines for compensation and care of mission personnel.
- 2. Develop a plan to underwrite the ministry of our Mission Co-Worker that reflects our national church's guidelines and be funded by a line item in our presbytery's budget in 2014; and if at all possible, appropriate adjustments be made to her terms of call in this calendar year.
- 3. Report to the Leadership Council at its April meeting so that the Council can make its report with recommendations to the Presbytery at its Stated Meeting in May.

Rationale: In a telephone conversation with Ben Albers in Louisville on January 17, Teaching Elder Liz Knott (HR) learned that the national church makes no distinction between clergy and lay mission workers in their salary. Their uniform start-up salary base for a single mission co-worker is \$29,920 for El Salvador. Following the national church's standards may enable us to meet our financial obligations more readily fair.

The assumption is that, since the Presbytery is calling and commissioning our Mission Co-Worker, she is a presbytery point of mission; therefore, she should be integral to our budgeting process and mission commitment.

Following discussion, the Presbytery VOTED to approve the recommendations.

VISITS WITH COMMITTEES, COMMISSIONS AND TASK FORCES

The Presbytery entered into a time of informal conversations with various Presbytery committees, commission, task forces, related organizations, staff members and each other.

LUNCH

The Presbytery recessed for a time to enjoy a delicious lunch provided by the folks from the Covenant Church. TE Jan Scott offered grace for the meal.

ANNOUNCEMENTS

The Presbytery reconvened with a time for announcements. Among these were: TE David Kincaide (Greenfield, First and Dexter, First) regarding a theological convocation to be held in Greenfield; TE Nathan Lamb (Hartford, Community United) regarding proposed changes by the Board of Pensions in medical dues payments; RE Darlene Shepherd (Oskaloosa, First) informing the Presbytery about the Older Adult Ministries Event; TE Mark Davis (Clive, Heartland) inviting the Presbytery to participate in

Teaching Elder Mark Davis, using the symbol of running water, encouraged Katherine to fill up and live it up as she does thoughtful work. His charge to her was, "Whatever Jesus says, do it!"

Phil also reported on the death of the Rev. Harold Butz, an honorably retired member of the Presbytery.

He then shared thoughts on some reasons why people are not attending churches and the things that chase people away.

BILLS AND OVERTURES TASK GROUP

Teaching Elder Shamaine Chambers King, a member of the Task Group, presented the report. (The written Report with comments and recommendations appears as **Appendix C** at the end of these Minutes.)

E-R-1 The Task Group recommended concurrence with the Proposed Amendments to the Constitution of the Presbyterian Church (U.S.A.).

In an omnibus motion, the Presbytery VOTED to concur with the following Proposed Amendments:

PTIZER ADMINISTRATIVE COMMISSION

TE Jim Howland presented the Report.

The Presbytery VOTED to adopt presented the following recommendations from the Commission:

- O-4-R-1 That the \$9,928.01 obtained from the sale of the property of the former United Presbyterian Church of Pitzer be placed in the Presbytery's Albia Sale Fund.
- O-4-R-2 That the name of the Albia Sale Fund be changed to the Albia-Pitzer Fund.

Rationale:

Since the church was a rural church in Madison County located in the area of the former community known as Pitzer, the Commission felt that the funds should continue the ministry legacy of rural churches. In reviewing the intentions of the monies currently located in the Albia Sale Fund, the Commission felt that the use of funds for small member congregational needs fit well with the history and nature of ministry of the United Presbyterian Church of Pitzer.

In addition, the Commission desired to continue the memory of this congregation's ministry in the years to come, so felt changing the current name of the Albia Sale Fund by adding the Pitzer name would help carry the legacy into future generations.

LEADERSHIP COUNCIL

Presbytery Moderator Jim Howland presented the report on behalf of Council Moderator RE Leland Smith.

The Leadership Council presented the following items of information to the Presbytery:

- E1-I-1 The Council will be holding its annual planning/visioning retreat on February 15.
- E1-I-2 The Council discussed how it might interact with the Budget and Finance Committee in helping Commissioners and Members better understand the budget process and what exactly is done through the budget.

The Presbytery VOTED to adopt the following recommendation from the Council:

E1-R-1 That the Administrative Commission dealing with the closing of the United Presbyterian Church of Pitzer be dismissed with our thanks for its hard work.

Presbytery Moderator Jim Howland assumed the Chair.

COMMITTEE ON PREPARATION FOR MINISTRY

TE Sue Tomlinson, Moderator of the Committee, presented the Report.

The Committee presented the following recommendation to the Presbytery for adoption:

BUDGET AND FINANCE COMMITTEE

RE Gary Modlin, moderator of the committee, presented the Report.

Gary called our attention to the Proposed Income and Expense Budgets for 2013, Gary explained that, due to income from a fund that GuideOne Insurance had been holding on our behalf and from the resignation of the Director of Communications, the Presbytery ended 2012 with a surplus.

Corrections were made to two items in the Personnel Section of the Proposed Expense Report:

2012 Actual Column -

- Part Time Helper Wages and FICA should be moved down to the Hunger Action Enabler Benefits and FICA locations
- Hunger Action Enabler Benefits should be moved down to Sudanese Ministry RP Salary

APPENDIX B

J – REPORT OF THE GENERAL PRESBYTER

January 19, 2013

Like most teaching elders, I enjoy reading. Believe it or not, one type of reading I like to do is church newsletters. This probably sounds strange to many of you, but reading your newsletters does at least two things for me. First, it helps me learn what's going on in our congregations. It is hard to keep track of all that's going on in our presbytery, so your newsletters help me be aware of what's happening around our presbytery. The second thing is that I get lots of helpful information beyond shat activities are happening. I glean wisdom and insight from what others have been learning and saying.

For this meeting, I'm thankful to Suzanne Gorhau, Pastor of the Centerville Church, for calling my attention to a piece related to a subject many of our congregations seem to focus on – being a successful church. She shares a blog post by Presbyterian minister J. Barrett Lee entitled *A Growing Church is a Dying Church*. Here's what he says:

"Whenever a congregation goes looking for a new pastor, the first question on their minds when the committee interviews a new candidate is: Will this pastor grow our church?

"I'm going to go ahead and answer that question right now: No, she will not.

"No amount of pastoral eloquence, organization, insightfulness, amicability or charisma will take your congregation back to its glory days.

"What then *can* your pastor do? She can make your board meetings longer with prayer and bible study. She can mess with your sense of familiarity by changing the order of worship and the arrangement of the sanctuary. She can play those strange new songs and forget about your favorite old hymns. She can keep on playing those crusty old hymns instead of that hot new contemporary praise music. She can bug you incessantly about more frequent celebration of communion. She can ignore your phone call because she's too busy praying. She can ruin your perfectly balanced budget with appeals for more funds to be allocated toward mission and outreach. She can take up your precious evenings with kooky new book studies and meditation groups. She can take up your precious weekends with exhausting volunteer projects. She can open your church building to the ugliest and meanest freaks in town, who show up at odd hours, beg for handouts, track muddy snow into the building, leave their cigarette butts in the parking lot, and spill their coffee on the carpet during their Junkies Anonymous meetings.

"She can come off sounding like a Jesus freak evangelical, gushing on and on about the Bible and your personal relationship with God. She can come off sounding like a smells n' bells Catholic, pontificating on and on about tradition and sacraments. She can come off sounding like a bleeding-heart liberal, prattling on and on about social justice and the need to constantly question old interpretations.

"What can she do to grow your church? *Nothing*. There's nothing your pastor can do to make your church grow. She can't save your church. Your church already has a Savior and it's not her. She can push you. She can open doors. She can present you with opportunities. It's up to you to take advantage of them. She can plant seeds and water them. It's up to god to make them grow.

"And what if that happens? What will growth look like? Will all those old, inactive members suddenly return? Will you need to start a second service and buy the lot next door in order to expand the parking lot? No. You *might* see a *few* new faces in the crowd. There won't be many of them. Some might stick around but most won't. Those who stay won't fit in with the old guard. They won't know about *how you've always done it.* They'll want to make changes of their own. Their new ideas will make you uncomfortable. Your church won't look or feel like it used to. You'll feel like you're losing control of this place that you've worked so hard to preserve. It will feel like your church is dying.

"And that's just the thing. A growing church is a dying church. It has got to be. It cannot be otherwise. The way to Easter Sunday goes through Good Friday. The way to the empty tomb goes through Golgatha. The way to resurrection goes through crucifixion. When Jesus told you to take up your cross and follow, did you expect it to lead anywhere else? What Jesus told us about himself is also true of churches: *Unless a grain of wheat falls to the ground and dies, it bears no fruit.*

"But what if it doesn't work? What if you let your pastor do all that crazy stuff and nobody new shows up? What if the church still goes under? What if all that time you spend studying the bible, expanding your horizons, deepening your spiritual life, and serving your community turns out to be time waster? What if it does?

"Tell you what: if that's what happens, if you commit yourself to all this and still feel like it was a waste of time in the end, then maybe your church really needed to die."

Some thought-provoking words: I wonder what the conversation might look like if, using Pastor Lee's words as a starting point, we started a new conversation about what makes a church successful.

I have been somewhat successful in getting out and about, and in connecting with various folks and groups. Since we last met, this has meant:

- Attended a "Crossroads" Event featuring one of the editorial staff of the *Des Moines Register* discussing how the Editorial Board of the paper makes its decision on persons/items the paper endorses during the election process
- Got my first real vacation in the year
- Resourced the Synod Personnel Committee as it did annual reviews of the Synod staff and as it interviewed candidates for the Interim Synod Executive position

- Attended one of my annual study leave events the Western Area Staff Conference in Burlingame, CA
- Attended the Retired Pastors' Christmas Lunch at Bob and Jeanne Burnett's home
- Met with representatives of the Lee Agency which manages our Presbytery insurance
- Represented the Presbytery at the Memorial Service for former General Assembly Moderator Cindy Balbach in Arlington, VA
- Hosted Des Moines area ecumenical leaders
- Met with several pastors
- Met with Gary Gansmer, Executive Director of Hillcrest Family Services in Dubuque
- Visited the Ankeny Church for worship
- Participated in the Installation of Tom Conrey as Co-Pastor of the Berwick Congregational Christian Church

As we begin a new calendar year together, I continue to be thankful to serve with you and I look forward to discovering what surprises God has in store for us this year.

APPENDIX C

E-1 – BILLS AND OVERTURES TASK GROUP REPORT

January 19, 2012

The Task Group recommends the following actions to the Presbytery:

E1-R-1 Proposed Amendments to the Constitution of the PC(USA) –

12-1 Heidelberg Catechism: On Amending the *Book of Confessions 4.001*

YES

Brief Description

The Special Committee on the Heidelberg Catechism was appointed in response to the action of the 218th General Assembly (2008) to correct specific translation problems in five sections of the Heidelberg Catechism in *The Book of Confessions*. The 219th General Assembly (2010) took action to instruct this already constituted special committee to recommend to the 220th General Assembly (2012) a new translation of the Heidelberg Catechism in cooperation with the Christian Reformed Church in North America (CRCNA) and the Reformed Church of America (RCA). The special committee continued to work with the representatives of the CRCNA and the RCA in finalizing a common new translation of the Heidelberg Catechism that was in keeping with the original 16th century versions of the catechism.

The special committee unanimously approved the common new translation and recommended this new translation to the 220th General Assembly (2012). The CRCNA and the RCA, in their respective national synods, have approved the new translation. Regarding inclusion of appropriate Scriptural citations, the special committee decided to restore the Scripture citations that were originally published with the Heidelberg Catechism in 1563. The hope of the special committee was to give the catechism back to the church in full as it was first presented, with the Scripture citations that allow the readers to explore the text in conversation with the texts of the Bible that informed the people who wrote it.

Assembly Action

The vote of the Confessions of the Church Committee on this amendment was 28 for, 1 against.

Rationale for Recommendation

- This amendment will fix the 30 to 40 serious problems with the previous translation in this document that was intended to be ecumenical.
- Question 87 contains the word "homosexuality" which had been added in the 1960's and is not a term used in the Latin or German.
- The more correct translation reminds us that we are called to live in holiness and chastity.
- This translation returns us to the original text, not just for the PC(USA) but also two other denominations who are more impacted by this than our denomination.

12-A Business Proper for Congregational Meetings – On Amending G-1.0503 YES

Brief Description

The Presbytery of Plains and Peaks, originators of the proposal provided this description: The adoption of the revised Form of Government in 2011 was intended to create greater flexibility in governance to meet the mission needs of congregations. However, in the revision of former G-7.0304, language was removed that had provided congregations the power to conduct business necessary for the government of the church.

Assembly Action

The Assembly Committee on Church Polity voted 34 in favor, 6 against and 2 abstentions. The General Assembly approved the proposed amendment on a voice vote.

Rationale for Recommendation

Adding this subsection is necessary and a good change.

12-B Gifts and Qualifications – On Amending G-2.0104a

YES

Brief Description

This overture would amend G-2.0104a by inserting as the fourth sentence the following: "This includes repentance of sin and diligent use of the means of grace." The effect of the insertion of this sentence is to define the requirement of the third sentence that those called to the church's ordered ministry exhibit a manner of life that is "a demonstration of the Christian gospel in the church and in the world" by requiring repentance and diligent use of the means of grace.

Assembly Action

The Assembly Committee on Church Orders and Ministry voted 28 in favor, 20 against and 5 abstentions. The General Assembly approved the proposed amendment with 329 in favor, 275 against and 9 abstentions.

Rationale for Recommendation

- This would return "repentance of sin" and "means of grace" language back to the *Book of Order*.
- This amendment reaches out to those who supported G-6.0106b in the old Form of Government.
- The promise to use the means of grace was in some previous ordination questions.
- This stresses to church leaders that this is an example to be set.
- The admonition to use the means of grace is in the *Rules of Discipline* (D-12.0102).
- Why wouldn't we want to include repentance? It's the reason for Christ's dying for us.

12-C Presbytery Registers – On Amending G-3.0104 and G-3.0305

YES

Brief Description

This amendment began as an editorial correction request because the current text of G-3.0104 contains a mixture of elements that would properly be separated into different provisions.

Assembly Action

The Assembly Committee on Church Polity voted 42 in favor, 0 against. The General Assembly approved the proposed amendment on a voice vote.

Rationale for Recommendation

This would bring clarity to two sections of the *Book of Order*.

12-D (Items D-1 through D-9) Shared Synod Permanent Judicial Commission

YES

Brief Description

This proposal actually involves 9 amendments that came as the result of a referral from the 219th General Assembly (2010) to develop and report constitutional amendments to provide for two or more synods sharing common boundaries to form a shared permanent judicial commission.

Assembly Action

The Assembly Committee on Mid Council Review voted 52 in favor, 0 against. The General Assembly approved the proposed amendment by a voice vote.

12-E Enrolling Ruling Elders as Members of Presbytery – On Amending G-3.0301 YES

Brief Description

This proposal would clear up any question regarding enrollment of ruling elders as members of presbytery while providing flexibility to presbyteries in determining their membership.

Assembly Action

The Assembly Committee on Church Polity voted 38 in favor, 5 against and 1 abstention. The General Assembly approved this proposed amendment on a voice vote.

Rationale for Recommendation

This proposal gives clarity to allow ruling elders who are Moderators of committees or commissions to be enrolled as members of the presbytery during their time of service. In many presbyteries, it would help in the balance of commissioners.

12-F Concurrences for Overtures – On Amending G-3.0302d

YES

Brief Description

The original proposal would have required concurrence of at least 10% of the presbyteries in order to present an overture to the General Assembly with the intent of improving the collaboration among presbyteries and to assure that the business before the General Assembly was of common concern to the mission of the church. The proposal was amended to require concurrence of only one other presbytery. Part of the rationale for this was that not all business is of concern to all presbyteries, for example, transferring a congregation from one presbytery to another.

Assembly Action

The Committee on Review of Biennial Assembly voted 24 in favor, and 2 against. The General Assembly approved the proposed amendment on a voice vote.

Rationale for Recommendation

- This proposal can help reduce the amount of proposed amendments coming to an Assembly.
- This action would help encourage the connectional nature of our denomination.

12-G Service of Ordination, Installation, or Commissioning – On Amending W-4.4002 YES

Brief Description

This overture proposes to have ordination and installation services scheduled at a convenient time to enable the substantial participation of the presbytery.

Assembly Action

The Assembly Committee on Theological Issues, Institutions, and Christian Education voted 21 in favor, 6 against and 2 abstentions. The General Assembly approved this proposed amendment by a voice vote.

Rationale for Recommendation

- This would increase the opportunities for members of the presbytery to attend these important functions.
- Our presbytery already follows the intention of the proposal.

12-H Jurisdiction in Judicial Process – On Amending D-3.0102b(2)

YES

Brief Description

Since there is no longer a provision for "laboring outside or within the bounds of a presbytery," changes that were made to D-3.0101b(2) created a situation which made the entire paragraph moot. This proposal intends to remedy this language problem by restoring the clarifying language present in the previous Form of Government and so that those serving the councils of the church may be accountable to the councils, agencies and partnerships for which the service is rendered, and to the presbytery of membership for the purposes of discipline.

Assembly Action

The Assembly on Church Polity voted 43 in favor, 0 against. The General Assembly approved the Proposed Amendment by a voice vote.

Rationale for Recommendation

This proposal provides clarification and flexibility in the disciplinary process.

12-I Administrative Leave – On Amending D-10.0106

YES

Brief Description

The intent of this proposal is to allow the use of administrative leave in any case involving an alleged offense of sexual abuse toward any person without the current limitation that the alleged offense be toward a person under the age of eighteen or who is alleged to lack the mental capacity to consent.

Assembly Action

The Assembly Committee on Church Polity voted 41 in favor, 0 against and 3 abstentions. The General Assembly approved this proposed amendment by a voice vote.

Rationale for Recommendation

- This proposal opens the administrative leave process to any allegation of sexual misconduct.
- The recommendation also provides some protection for the accused person.
- The recommended process is consistent with what happens with such situations in other parts of our society.
- Misconduct actions are harmful for those over 18 as well.

12-J Investigating Committee Responsibilities – On Amending D-10.0202

YES

Brief Description

The recommended language would allow the investigating committee to first determine whether the statement of an alleged offense, if true, constitutes an offense as defined in the *Rules of Discipline* in D-2.0203b, and if not can end its inquiry without conducting a full investigation.

Assembly Action

The Assembly Committee on Church Polity vote 42 in favor, 0 against and 1 abstention. The General Assembly approved this proposed amendment with a voice vote.

Rationale for Recommendation

- This proposal clarifies who has the responsibility for determining actions requiring discipline.
- It can help reduce the time involved in an investigation.

With your help we can continue to make a difference together in 2013!



THE POVERTY LINE

- Assisted 377 households representing 763 individuals with rent, deposits, mortgage, or utility bills to prevent homelessness.
- Provided 626 households representing 1,799 individuals with personal hygiene items, cleaning supplies, laundry vouchers, bus tokens, baby items, and/or storage costs for households in transition.
- In partnership with the Des Moines Area Religious Council gave food boxes 1,756 times feeding 5,243 hungry bodies (some duplicated).
- Served 1,500 children from low income households with a new backpack filled with grade appropriate school supplies.
- Advocated to improve the quality of life for all lowans facing issues of poverty.
- Offered informational lectures, sermons, and workshops on poverty.

are the foundation of our organization providing over 2,000 hours of dedicated labor each year, most notably in the operation of the CROSS Food Pantry, the Annual Back to School Giveaway, and with fundraisers. Special thanks go to Joyce Hoffman for the many hours she spends coordinating those volunteers.

Making a difference one family at a time!

Carla, Ron and their eight year old daughter are typical of many low income households struggling to make ends meet. Even in the best of times, their financial situation was challenging. Then one day while doing some odd jobs, Ron fell off the roof of a house and severely injured his back. As an independent contractor who wasn't able to work for several weeks, the family struggled to meet even their most basic needs. CROSS came to the aid of this family assisting with a portion of the rent because they were not eligible for governmental assistance.

Homelessness Prevention

CROSS Ministries, formed in 1974, is a social outreach ministry of Cottage Grove Avenue Presbyterian Church with the financial support of the Presbytery of Des Moines and its member congregations. Additional funding sources include grants from Prairie Meadows, the Iowa Finance Authority, fundraisers, churches, and private donors. Food grants are received from the Des Moines Area Religious Council (DMARC) Food Pantry Network.

CROSS provides direct financial emergency assistance to low and no income households for homelessness prevention and utility bills; assists with a one week supply of food once every calendar month; and provides an array of basic needs including personal hygiene boxes, cleaning supplies, bus tokens, and laundry vouchers.

Back to School Giveaway

Recognizing that education is an important step in ending the cycle of poverty, for the 20th year CROSS has provided a new backpack filled with grade appropriate school supplies to the children of low and no income families. While the Giveaway is one of the most labor intensive endeavors of each year, with approximately 140 volunteers of all ages providing more than 450 hours of work, it is also one of the most rewarding! This year CROSS was able to provide supply packs and reading books to 1,500 children!






Through a partnership with the Des Moines Area Religious Council (DMARC) Food Pantry Network, in 2010 CROSS Ministries opened the first alternative hours food pantry. Recognizing that many of the working poor are unable to access food pantries during standard business hours, the opening of a centrally located evening and weekend pantry, and without geographic boundaries, helped to ensure greater food access for all.

With more than 30,000 residents of Polk County living at or below the poverty line, it isn't surprising that 20% of children in Polk County live in households without enough food. As a result,

CROSS works to end food insecurity. Special thanks to Trader Joe's for supplementing our pantry with extra produce, breads, and even flowers and thanks to JOPPA Outreach for delivering the items to our door!
